BOND(S) AND CONSTITUTIONS
AND NOMINATION AND APPOINTMENT
OF FIDUCIARIES**

**MANDATORY JUDICIAL NOTICE OF
11 USC 904 LIMITATION ON JURISDICTION AND POWERS OF COURT**

1 Comes now barry halajian, as the Municipal Corporation debtor, pursuant to Rule 201, Fed. R.
2 Evid., and files this Motion For Court To Take Judicial Notice of 11 USC 904 limitation on Jurisdiction
3 and Powers of Bankruptcy Court Chapter 09 Bankruptcy Case # 12-15132-9 that should be marshaled
4 into this bankruptcy case as follows:

5 I barry halajian, am the Municipal Corporation Debtor/Indenture Trustee as the following
6 Artificial Persons; the Indenture Trustee and the official Corporate US citizen/employee as the Debtor of
7 the above named municipal corporation known as the BARRY STUART HALAJIAN - SS Municipal
8 Corporation Account XXX-XX-5949, and that this statement is in support of the Bankruptcy rules being
9 deemed filed under a "Private Bankruptcy Miscellaneous Filing" for this special Chapter 9 Municipal
10 Bankruptcy Liquidation case as private action between the Judgment Debtor and the Judgment Creditor.

11 As the Municipal Corporation Debtor; I, Do Not give permission bbbor consent to the Court (*per* 11
12 *USC sect. 904*) of any the private municipal corporation governmental jurisdiction or power to Interfere
13 with this private municipal transaction. This is a private matter being performed to complete the ACT OF
14 CESSION OF GOODS to transfer all assets held by the Debtor over to the Alive Creditor that was
15 publicly posted and was never rebutted per the Law so it stands as a Fact in Law. Barry Halajian is the
16 only movant in this bankruptcy estate and consents to no other. This court will take no action and will
17 allow no action without first requesting in writing permission of barry halajian, and receiving from barry

23 **MUNICIPAL CORPORATION:** A public corporation, created by government for political purposes,
24 and having subordinate and local powers of legislation. An incorporation of **persons** having the powers of
acting as one person.

25 **11 USC 904. Limitation on juri diction and powers of court**

26 Notwithstanding any power of the court, unless the debtor consents or the plan 0 provides, the
27 court may noi, by any stay, order, or decree,
28 in the case or otherwi e, INTERFERE with-
(1) any of the pol itical or governmental power of the debtor;
(2) any of the property or revenues of the debtor; or
(3) the debtor's lI e or enjoyment of any income-producing property.

1 **NOTICE OF NON-NEGOTIABLE ACCEPTANCE OF**
2 **OATH(S) OF OFFICE, BOND(S) AND CONSTITUTIONS**
3 **AND NOMINATION AND APPOINTMENT OF FIDUCIARIES**

4 Notice to All Defendants in this matter: Upon my word, in recognition of your mandated service
5 to the community and with all due respect, honor, peace and grace halajian hereby acknowledges, accepts,
6 captures and seize the OATH(s) of office and bond(s) of: all defendants as well as any and all others
7 defendant(s) have hired or will hire in any manner with regards to any dealings and/or affairs of halajian
8 and all above nominated and appointed Fiduciaries (hereon known as Fiduciaries), executed on the date of
9 acceptance of your office(s), and bind you (ALL of you) to your oaths and the mandates required of you
10 as a result of your oath(s): In making this non-negotiable acknowledgement, acceptance, capture and
11 seizure of your oath as a lawfully binding contract between barry halajian and all defendants, and
12 mandates created by all defendants Oath(s) of office, I, the undersigned admit the existence, reality or
13 truth of above entitled Oath(s) and Bond(s) and recognize that these are valid as having force and point of
14 LAW and that I duly accept the same as lawfully binding. We have a meeting of the minds.

15 Also, barry halajian hereby nominates and do appoint defendants (now Fiduciaries) as being
16 qualified to fulfill the position of "Fiduciary" for halajian, the same to be effective immediately as of the
17 date set forth below and is **non-negotiable. This is a mandated, non-discretionary BINDING contract**
18 **between you (defendants) and me in our private venue and capacity and is formed and**
19 **memorialized: you acknowledge that your oath(s) indebt you to me and you are required by law to**
20 **honor this presentment and your duty to me.** The term of this contract is for the life of the offerees and
21 shall apply to all of your successors and continues until further noticed by halajian within the venue as
22 ordained and established by the People of california through their original Organic Constitution and
23 Organic Laws of America.

24 I reject and discard as defective all other Oaths and or Allegiances you have as they are breaches
25 against your Natural bond as a sovereign of your Birthing Land and the state and/or federal Office you
26 occupy and receive Payment and/or wages. This includes the one to allow the UNITED STATES "as
27 artificial organizations of corporation" to claim you as a subservient Citizen of theirs. Others would be
28 "Oaths of Loyalty" to any association such as the BAR, because they conflict with the "Oath of Office" of
which you are holding; for one cannot serve two masters at the same time. You each are to provide me a


1 certified copy of your Oath of office within 10 days of this notice. I have taken no oath to uphold and/or


